## ABSTRACTS

### **(1) Understanding and Thinking about the New Normal of the Economy** *Han Yongwen*

Recognizing the new normal, adapting to the new normal, and leading the new normal, is the large logic of China's economic development in the current and future periods. This paper deeply analyzes the risks, challenges and opportunities of China's new normal economic development. This paper holds that the new normal must be comprehended accurately and economic development should be advanced through reform and innovation to a high-end level.

### **(2) Attaching Great Importance to Deal with the Economic Downward Pressure**

*Zheng Xinli*

In order to solve the current economic downturn and sluggish growth problems and achieve the target on steady growth, we must, starting from expanding domestic demand, appropriately crack the problem of insufficient demand. Strong measures should be taken to overcome the inertia of economic downturn, and monetary growth speed should be kept at a rate higher than under normal circumstances; it's a correct move to implement moderate monetary policy through the reduction of interest rates and RRR for the sake of steady growth, structuring adjustment and anti-risk. Focus on the rural reform according to principles of the three rights division among ownership, contracting, and management is the fundamental path to achieve steady growth, and farmers should be allowed to mortgage, guarantee, transfer contracted land management rights, and develop the land-scale, professional, modern management, so as to increase agricultural productivity.

### **(3) Increasing the Economic Strategic Depth to Enhance China's Anti-impact Toughness**

*Huang Zhiling*

Further study of economic strategic depth can make full use of the actual and potential strategic depth, which can not only enhance the toughness of economy against external malicious impact, but also help economic development get out of the trouble and eliminate the potential risks, and then enter a new cycle of growth. Historical experience shows that where there is no economic depth, there is no economic security. In recent years, with the expansion of the international economic and trade activities, China's economic strategy has not been expanded, and even has been squeezed. With the continuous rise of the Chinese economy, contradictions between the world's major economies are inevitable. China should not only have normal psychological preparation to cope with the daily economic contradictions and frictions, but also advance research and prepare to deal with extreme external shocks, construct the strategic depth to ensure the economic security as soon as possible.

#### **(4) On Deepening All-round Pension Reform**

*Tian Xueyuan*

At present, the comprehensive top-level design is the main orientation and focus of pension reform. A comprehensive pension system and mechanism should be constructed on the basis of clarifying the historic, current and future's evolution of Chinese-style pension, clarifying the institutions and mechanisms of old-age security, pension insurance, and pension system. The core task is to deepen all-round pension reform, and establish a national unified, fair and sustainable pension insurance system.

#### **(5) Improving China's Social Governance System to Realize the Green Transformation of Economic Growth Pattern through Environmental Protection forces**

*Yang Zhaofei*

At present, the work of transforming the economic growth pattern and environmental protection in China has made positive progress. However, environmental situation is still grim. The current environmental regulation system has not adapted to the environmental situation. We must proceed from the perspective of modern governance system, clarify the idea of environmental supervision and re-build environmental regulation system, achieve economic transformation through environmental supervision and management. We need a radical reform of the system to improve the ability of social governance, including transforming the government's functions, streamlining administration and instituting decentralization, administering by law, strengthening the reform of environmental protection, reforming environmental supervision system, putting market into a decisive play in resources allocation, increasing the technology upgrade to promote pollution source management, cultivating social organizations with positive energy, referencing widely the experience of international environmental governance, and so on. However, at present, raising the awareness and changing ideas is the most important thing.

#### **(6) The Basic Ideas of Promoting the Eastern Region to Take the Lead in the Transitional development**

The eastern region plays an important role in the national economic development. With China's economy coming into the new normal, the transitional development becomes the main melody of China's economy. This article, starting from the significance of the eastern region taking the lead in the transitional development, clarifies the ideas to promote the eastern region to take the lead in the transitional development; then analyzes the key tasks of the transitional development in the four areas of the economy, society, government and ecology; finally, puts forward suggestions to promote the eastern region to take the lead in the transitional development.

#### **(7) Constructing the Eco-economy Belt on Huaihe River and Promoting the Whole Basin to Realize the Well-off Target**

The Huaihe river basin is the development depression of middle and east China. The Huaihe river basin needs to get rid of poverty and keep pace with the whole nation to realize the well-off target.
